Explain the importance of the problem or the source of development needs. Scope of research and benefits are expected. (Font size 12)

4. Research Methodology

Research Methodology (Font size 12 bold)

A presentation of data that is associated with the research or conceptual framework for research and presents the current population, sample group, sample sampling method, tools used in research, how to collect data, the duration of the data storage, and how to obtain the sample group. How to analyse data and information with others, the opinion focused on the acquisition of the findings. How could a qualitative research or quantitative research methods depend on the type of research. (Font size 12)

Result (Font size 12 bold)

Show the research results and various data obtained from the study, which should be presented per the objectives set. There may be illustrations, tables, or charts with understandable explanations. The research results should be consistent with the tables and pictures. (Font size 12)
